**TENDER NOTICE**

*Municipal Committee Khanewal Intends to call Sealed Tenders for its Development Projects pertaining to Punjab Municipal Services Program (PMSF) 2019 from contractors who are registered/renewed within any Local Government of Division Multan for the financial year 2020-21 in relevant category and deposited their Enlistment/Renewal Fee in any Institute of Local Government in Division on the following terms and conditions and on the schedule prescribed below.*

1. *The bid documents can be received on payment of **Rs.5000/-** per tender document from HC (Infrastructure) on written request by contractor accompanied with receipt of deposit of Tender Fee in Bank of Punjab attested photocopy of enlistment /renewal letter, ID Card of contractor, power of attorney of owner of firm from the date of publication of tender notice till to **24-07-2020**.*
2. *The sealed bid documents alongwith 5% of estimated price as bid security earnest money in the shape of Call at Deposit from any scheduled Bank in Punjab in favour of Administrator, Municipal Committee, Khanewal shall be deposited to Head Clerk (I&S) of Municipal Officer (I&S) Municipal Committee Khanewal from date of publication to **25-07-2020** at 02:00PM*
3. *All the received/sealed bids will be opened on dated, **25-07-2020** at **02:30 PM** in the office of Municipal Committee Khanewal by the tender opening Committee in the presence of available contractors or their authorized representative.*
4. *It is compulsory on all participated contractors to quote their rates in numbers as well as in words on above or below the estimate on percentage basis.*
5. *If the contractor poured lowest tender rates equal to and less than 5% of the estimated cost, the lowest bidder shall bound to deposit additional performance security from the scheduled bank from 5% to 10% (including CDR deposited at the time of tendering) within 15 days of issuance of notice. If he does not deposit the required amount, his 5% CDR deposited will be forfeited by the Municipal Committee and his tender rate will be rejected and process of re-tendering will be initiated. This action cannot be challenged in any court of law.*
6. *Conditional, un-signed, incomplete, cutting, overwritten and doubtful bids will be dealt as rejected.*
7. *The Competent Authority may reject all bids at any time prior to the approval/acceptance of the Tender rate.*

8. When work order issued to approve contractor, he has to make the agreement with Department on stamp paper of value specified by Government.
9. Time period for completion of each project will be mentioned in work order after approval of rates of the lowest bidder.
10. The bids poured by contractors without 5% CDR will be dealt cancelled automatically.
11. The sealed bids should be with original CDR. The bid document not issued from the office of Head Clerk (I&S) will be considered as rejected. The bidder has no right to challenge it.
12. The contractor to whom work order is issued is bound to conduct the required quality control tests on his own expenses.
13. The estimates are framed on MRS 2<sup>nd</sup> Bi-Annual 2019 and for non-scheduled items based on Market Rates.
