- (iv) Not be involved in litigation with any Government Department, Agency/Organization etc.
- (v) Have sufficient financial technical and human resources to complete the procurement within prescribed time limit on the finalization of contract.
- 7. Bidding Documents will be available immediately after publication of this notice and can be purchased from Office of Chief Officer, Municipal Committee Khanewal for a non-refundable fee of Rs. 10000/- for each set. Interested bidders may obtain further information from the same address.

Bids shall be valid for a period of 90-days after Bid opening and must be accompanied by bid security of amount mentioned above in the form of a Bank Draft or an irrevocable encashable on-demand Bank Call Deposit in favor of Chief Officer Municipal Committee Khanewal and shall be delivered on or before 20/07/2022 at 11:00 A.M. The bids shall be opened in the presence of the bidders or their authorized representatives who choose to attend on 20/07/2022 at 11:30 A.M on the same day at the above given office.
- A pre-bid meeting with contractors will be held on 16/07/2022 in the office of Chief Officer, Municipal Committee Khanewal and Interested bidders are invited for participation.
- 10.Last date of collecting the bidding documents is 18/07/2022.
- 11. The Bidding Procedure will be governed by Rule 38(2)a of PPRA, 2014 "Single Stage Two Envelopes" procedure. The bids shall be evaluated on the basis of qualification criteria provided in the bidding documents.
