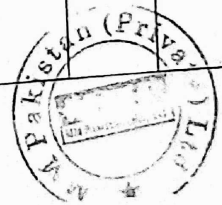


C. Remarks

- Out of 07 Firms, 05 Firms are qualified in Qualification Criteria for Technical Scores by scoring 75% & above. Whereas, Waheed Construction Company is registered and active for Income Tax in FBR but blacklisted for GST and Ch. Abdul Ghafoor Goheer is registered for Income Tax with FBR but not registered for GST. As such both Firms stand Disqualified.
- For Siddique Sons Construction Company, GST document was missing which was further verified from FBR website and found active and operative for Income Tax as well as GST.


