The chair welcomed all the participants. Following agenda of the meeting was

discussed in detail:-

Grievance of Ch. Abdul Ghafoor Goheer, Government Contractor regarding dis-qualification for construction of Roads PCP Programme Khanewal City

The representative of Municipal Committee, Khanewal submitted his report that 07 numbers of contractors / firms have submitted their pre-qualification documents for the construction of roads in Khanewal city under Punjab Cities Programme (PCP) in Municipal Committee Khanewal on dated 03-12-2022. Out of which 03 Nos. of contractors / firms have qualified and 04 Nos. of Contractor / Firms have dis-qualified by evaluation reports received from JERS Consultancy (PVT) Ltd. Vide No. 488-J01-16-40 dated 15-12-2022 and MMP Consultancy (PVT) Ltd. Vide No. MMP/PMDFC/1076/COM/369/2022 dated 20-12-2022, same evaluation reports were issued to Municipal Committee, Khanewal by Punjab Municipal Development Fund Company (PMDFC), Lahore. It was further informed that Contractor / Firm M/S Ch. Abdul Ghafoor Goheer has 02 NTN's as per detailed below:

1. NTN No.4678584-2 against Ch Abdul Ghafoor Goheer (Sales Tax Not Operative)
2. NTN No.1350788-5 against Ch Abdul Ghafoor (Sales Tax Operative)

The Contractor / Firm M/S Ch Abdul Ghafoor Goheer was disqualified by the Procurement Tender Opening Committee, MC Khanewal

While, Mr. Sheraz Ghafoor, Representative of the Contractor stated orally that Ch. Abdul Ghafoor Goheer and Ch Abdul Ghafoor is one person and both the NTN numbers belong to him. He also provided following documents:-

1. Copy of license issued from Pakistan Engineering Council
2. Form 181 (Order to grant / Refuse Modification to registration on application)

The firm Ch Abdul Ghafoor Goheer having Reference No. 4678584-2 is active for Income Tax with FBR but not operative for GST. On the other side Ch Abdul Ghafoor having Reference No. 1350788-5 is active for Income Tax as well as operative for GST. The reports of JERS Consultancy (PVT) Ltd., MMP Consultancy (PVT) Ltd. and PMDFC have dis-qualified Ch Abdul Ghafoor Goheer on the basis of none operative for GST in FBR. While the documents provided by the contractor as well as report of Municipal Committee, Khanewal, shows that the contractor has submitted documents having two NTNs (one is operative and other is not operative) with same name of the firm which also shows his malafidi. Therefore, grievance of the contractor is rejected.
