The chair welcomed all the participants. Following agenda of the meeting was discussed in detail:-

 Grievance M/S AKB 3P Solution JV, Government Contractor regarding Financial Bid evaluation for Comprehensive Sewerage System in Khanewal City (PCP)

The representative of Municipal Committee, Khanewal submitted all relevant record. After scrutiny of record it was found that the financial bids of qualified bidders (03 Nos.) were opened on 08-12-2023 and financial evaluation report was signed on 13-12-2023 and was approved by the competent authority of executing agency. The same financial evaluation report was uploaded on PPRA web site accordingly. The financial bids were checked in detail and it was found that the evaluation of financial bids were correct.

It was noticed that M/S AKB 3P Solution JV has not submitted two copies of financial bid. It was also noticed that M/S AKB 3P Solution JV has filled amount on the page of overall summary while other sub summary pages were blank, it indicates his mala-fide. It was further noticed that M/S

AKB 3P Solution JV has quoted unit rates of manholes which has been taken in evaluation, these rates cannot be considered as free of cost.

Both Contractors namely M/S Al-Shan and M/S AKB 3P Solution JV have quoted same unit rates Rs.2060 of boundary wall (quantity 2000 Rft) on the page No.280 of Financial Bid. The Tender Opening Committee has considered same unit rate for both contractors as they have quoted which is correct. The unit rates have not been cherry picked.

During examination it was found that Contractor M/S Al-Shan has quoted discount rate 13% for all quoted unit rates on the page of letter of financial bid (prescribed document), so his discount rate was applied in financial evaluation report. It is further examined that Contractor M/S AKB 3P Solution JV has not quoted discount rate on the page of letter of financial bid (prescribed document) and he has also not quoted discount rate on the page of overall summary, while he has quoted discount rate 7.2% on the page of Part-F, so his discount rate was correctly applied in financial evaluation report. After pursuance of the all record it is clear that financial evaluation report prepared by the executing agency is correct in all respect. Therefore, the grievance of the contractor (M/S AKB

3P Solution JV) is rejected.
